Accuracy in Accounting and Interest: Marwari Entrepreneurs were accurate in their accounting and interest calculations. They used to keep well maintained records of their accounts. Family business: they used to follow HUF system – which is called "Hindu Undivided Family" - this was the base of Marwari Entrepreneurs

Values of Respect to Environment: Marwari Entrepreneurs were following age old principles of Indian philosophy which were followed in India for an exceptionally long period of time. The basic idea was to respect nature, world ecosystem and environment. They would start their day with respect to Laxmi and Ganesha – which would symbolize respect to the universal spirit. They would respect Shubh and Labh which would mean respect to wellbeing of everyone and profits.

System of Gaddi: Marwari Entrepreneurs used to have their Gaddi-a type of office management where people would do their business using a traditional office system which is called Gaddi. There would be a Munim in every Gaddi who would be working as manager cum CEO for that business house. Munim would enjoy lifelong employment in the Marwari Enterprise and would be responsible to keep his Gaddi as a profit centre.

Decline of Marwari Entrepreneurship

Marwari Entrepreneurship has now declined and is on the verge of extinction due to changed socio-economic conditions and due to changing social values. Reducing family size has also resulted in decline of this branch of traditional entrepreneurship.

Need of Study

There is a need to conduct study on traditional entrepreneur





-ship which will help in development of new branches of entrepreneurship. These branches of study will become extinct in some years to come.
